- 5. CONSIDERATION and possible action of activating GEDCO's bank account online. John Paul Tallent made a motion that GEDCO's bank account not be activated online. Laura Talley seconded. Motion carried 5-0.
- 6. CONSIDERATION and clarification of check-signing procedures over \$2,000.00. After discussion, all checks written over \$2,000.00 for items purchased and contract agreements must be approved by the Board. John Paul Tallent made a motion that all checks over \$2,000 be approved by the Board. Luke Kimbrough seconded the motion. Motion carried 3 to 2.

The roof has continued to leak and the air conditioners need to be removed from the roof. - 11. CONSIDERATION and possible action on Gladewater Center for Community Education Building's roof. The roof on the GCCCE Building needs to be repaired because it is still leaking. Mark Carpenter made a motion that GEDCO contract with Longview Roofing to repair the roof for up to \$2,000.00. Luke Kimbrough seconded. Motion carried 5-0.
